## ENNs for FX Markets Update as of December 13, 2019

The tables below provide an update on the notional and entity-netted notional (ENN) size of the CFTC-regulated FX market. Entity-netted notionals for the FX and credit asset classes were introduced in a paper published in February 2019.<sup>2</sup> ENNs aim to provide a measure for the amount of risk transfer in FX swaps; FX ENNs are defined as risk-adjusted exposures netted within a counterparty and currency pair.<sup>3</sup> The tables below represent aggregated FX swap position data as of December 13, 2019 and are sourced from reports provided by registered Swap Data Repositories.

Compared to the prior report, notional and risk-adjusted notional values fell, while ENNs rose quarter-on-quarter. Clearing rates continue to remain relatively stable, at around 2 percent for the asset class as a whole, and led by NDFs with a current clearing rate of just under 22 percent.

Instead, risk-adjustments are restricted to just delta-adjustments for FX options. Tables include a "doubled-ENNs" column to highlight that both legs of the FX swap (and thus two distinct currencies) are included in all calculations.
